<sup>2</sup> Veterans, dependents, reservists, or active duty members using educational benefits are guaranteed submission of enrollment verification before the start of the upcoming semester if they have submitted the required documentation by the priority deadline date.

<sup>3</sup> All admission requirements must be submitted by this date; international students are only admitted for the fall and spring 16-week semesters.

<sup>4</sup> Some CWI offices may be closed over holiday weekends; see office hours published on CWI's [website](#).

<sup>5</sup> The academic calendar reflects regular 8-week session dates; please refer to the shorter *Class Session* sections (located beneath the full *Academic Calendar*) for important dates applicable to shorter sessions taught during the regular semester.

<sup>6</sup> Late adds are not allowed. Students are encouraged to look for options offered in the next term if they miss the registration deadline.

<sup>7</sup> Add/drop and refund deadlines vary for classes with start/end dates that are different from the regular semester dates. Please refer to the shorter *Class Session* sections (located beneath the full *Academic Calendar*) for applicable deadlines.

<sup>8</sup> Financial aid disbursements are credited to student accounts. After all institutional charges are paid, any credit balance available will be refunded.
